Candidates for Board of Directors

Adam Gerhardstein, 3-year term (term ends 2015)

I was born and raised in Cincinnati, Ohio, where I was a member of the First Unitarian Church of Cincinnati. After high school, I spent the following fall in Western Kenya as a Global Routes intern and taught in a local school. Upon my return to Cincinnati, I founded Ugali, an organization that supports communities and students in Western Kenya. I graduated from Xavier University in 2004.

In 2006, I moved to Washington, D.C., to work for the Unitarian Universalist Association's Washington Office for Advocacy. For two years, I served as the Legislative Assistant for International Issues, advocating for an end to the Iraq War, comprehensive HIV/AIDS prevention programs, and substantial action to end the genocide in Darfur. In 2008, for one year, I served as the Acting Director of the Washington Office, where I oversaw the office's advocacy for lesbian, gay, bisexual, and transgender equality, comprehensive sexuality education, immigration reform, and more.

In June 2009, I became the founding Campaign Manager of the Standing on the Side of Love Campaign (SSL). SSL is a public advocacy campaign sponsored by the Unitarian Universalist Association that harnesses love's power to stop oppression. Modeled after a political campaign, SSL uses online and onthe-ground organizing, policy advocacy, prayer and public witness to stand up to identity-based exclusion, oppression and violence. I organized over 1000 people to join the March for LGBT Equality, walked the Trail of Dreams to bring attention to the road to nowhere that undocumented immigrant youth face, mobilized over 150 congregations to re-imagine Valentine's Day as International Standing on the Side of Love Day, and played a central role in bringing marriage equality to our nation's capitol. When SSL turned one-year old it was firmly rooted throughout the country and I decided to step down from my position to attend law school in Minneapolis. By learning the law, I am expanding my capacity to work for justice as I understand the foundations of power.

I am passionate about Unitarian Universalism and I believe the CLF is at the leading edge of making our faith relevant, accessible, and powerful in this rapidly changing world. I plan on helping the CLF continue to push that envelope by lending my experience building movements within Unitarian Universalism that challenge and expand our faith.

Arif Mamdani, 3-year term (term ends 2015)



Arif has worked in nonprofit organizations for more than twelve years. Most recently he held posts at Progressive Technology Project (PTP) as its Executive Director and, prior to that, as its Capacity Building Program Director. At PTP, he created and led the organization's signature training and technology programs. Though his work has been technology driven, it has focused on supporting non-profit organizations in realizing their aspirations, with technology as a tool in the service of social change. For the last six years, he has been on a

path of personal transformation and spiritual practice. He is also a graduate of the Year-Long Fellowship program at Rockwood Leadership Institute.


